The following topics will be raised this semester and throughout the academic year for discussion in SACUA. Discussions are likely to result in action items for SACUA and Senate Assembly:

Propose a resolution to support the Latinx and all ethnic members of the University community

Clarify the role of UM-Ann Arbor faculty governance as it relates to UM-Flint and UM-Dearborn campuses (e.g., continuation of the Tri-Campus Task Force)

Discuss Diversity, Equity and Inclusion (DE&I), core University values, and the role of faculty. We hope to also promote and participate in campus-wide difficult conversations about DE&I matters in safe and courageous spaces

Work with the University community in proactive ways and as an emergency response to address emerging and urgent campus-wide matters

Discuss increased faculty grievances and training Faculty Grievance Monitors

Clarify the role of Ombudsperson at the unit and University levels

Re-institute the Civil Liberties & Civil Rights Committee with priorities focused on faculty perspectives on several emerging campus-based issues relevant to freedom of assembly, expression and speech; use of social media, academic freedom; immigrant rights and access to higher education; etc.

Evaluate the instruction platforms including the phasing out of C-tools as well as Canvas and Duo

Discuss faculty evaluations of administrators

Discuss SACUA members and importance of increased interactions with Regents
