Summary: The topics of focus for the year 2021-2022:

**Summary Topic 1 - Anti-Discrimination Language**. After presentations by Professor Dinesh Pal on the history of caste discrimination in South Asia, and Professor Duxin Shen on the harassment of Chinese researchers due to the federal government's China Initiative. We drafted and submitted to SACUA Anti-Caste discrimination language, Anti-Chinese discrimination language as a result of the federal government's China Initiative, and anti- Southeast Asian discrimination language as a result of the pandemic. The language was reviewed and edited by SACUA for final approval.

**Summary Topic 2 – A Public Webinar Event.** We planned and hosted a webinar entitled "Anti-Racism and Faculty Success: A Conversation" on April 12, 2022: The committee discussed at length the possibility of two public events. One would feature a costly, nationally known speaker, and another event would feature a more affordable local speaker. We decided to have one event and feature local speakers among our Black faculty. They participated free of charge and presented a lively and informative conversation on from 4-5:30pm on April 12, 2022.

**Summary Topic 3** – Nomination of Chair for Faculty Senate Award. Members of CAR, led by Dr. Michael Brenner prepared for submission and outstanding dossier for consideration of the University Librarian Achievement award.

**Summary Topic 4** – Follow Up for the Future: We met with Dr. Robert Sellers who recommended that we speak with Dr. Tami Strickman from ECRT regarding the inclusion of anti-discrimination language into the university's official anti-discrimination language. The chair also wanted to speak with Dr. Strickman regarding the anti-racist reporting mechanism of CAR. The chair met with Dr. Strickman on June 21<sup>st</sup> to discuss the issues above. We agreed to meet with Dr. Tabbye Chavous, Ms. Tanisha White, and Dr. Tami Strickman to discuss these issues, and wrap up the committee's work in order to transfer to new committee leadership.

**Summary Topic 5** – The Future: Ask the Provost and ADVANCE for a Salary Equity Review. We would like to go public with our reporting mechanism with the support of other departments. Determine when to retain autonomy, and when it is best to partner.
