2. <u>Discuss what metadata/inferential analysis committee would like to conduct</u>

- a. The committee discussed the division/analysis of the report data.
 - i. Committee members decided that they would divide the open-ended questions amongst members for analysis.
 - ii. Systematic approach to how to summarize the data with consistency across the different questions.
 - iii. Coding keywords and then creating categories for them, identify underlying themes, and the critical topics committee would like to highlight.

 - v. Committee decided to run a supervised approach to data analysis as it will generate more meaningful results.
 - vi. Committee members will review assigned question responses to identify keywords to be provided to committee member Felix Karbo by March 11 to begin running initial analysis.

- b. Committee members will write their sections of the report based on the questions assigned.
