Monday, September 18, 2023, 3:00

**3:00 Call to Order** – The meeting was called to order at 3:02. The minutes were approved by consent. There were no announcements.

## **3:05 SACUA Chair Updates:** The chair reported three items:

- (1) He thanked SACUA for taking time to attend the retreat on Friday September 15th. The group voted for two goals: (A). repair grievance procedures and (B). clarify the meanings and protections associated with tenure.
- (2) Both the chair and the FSO director met with Amy Stillman, Chair of Native American Studies in the Department of American Culture regarding the building of a new, larger commemorative monument. In 2018 Native American students compiled a report with many recommendations, none of which have been implemented. There are many issues to consider, and this is still a work in progress.
- (3) The chair and the director met with President Ono to discuss how to best use their time together. The topics which rose to the top were a childcare facility for Ann Arbor Central Campus and more affordable housing for graduate students.

## Questions:

- (1) It was asked if the childcare request applied to the regional campuses as well? The response was 'no", but that SACUA will bring this up.
- (2) It was asked if childcare was one of the two items that were voted on at the retreat. The response was that it was an additional issue to bring up, like the salary study. These are additional suggestions to pursue throughout the year.

**3:15 FSO Director Updates:** – There was no director's written report, but he touched on two items:

- (1) the Open Meetings Act question raised at the retreat. The act does not apply to SACUA, but SACUA can make its own determinations about which parts of meetings should be open to the press and which parts should not.
- (2) The director sent liaison assignments to the group. The FSO will send us a general

University of Michigan Bylaws of the Board of Regents, Sec. 5.02: Governing Bodies in Schools and Colleges

Sec. 4.01 The University Senate

"...[t]he Senate is authorized to consider any subject pertaining to the interests of the university, and to make recommendations to the Board of Regents in regard thereto. Decisions of the University Senate with respect to matters within its jurisdiction shall constitute the binding action of the university faculties. Jurisdiction over academic polices shall reside in the faculties of the various schools and colleges, but insofar as actions by the several faculties affect university policy as a whole, or schools and colleges other than the one in which they originate, they shall be brought before the University Senate."

Rules of the University Senate, the Senate Assembly and the Senate Advisory Committee on University Affairs:

Senate: "In all cases not covered by rules adopted by the Senate, the procedure in Robert's Rules of Order shall be followed."

Assembly: "The Assembly may adopt rules for the transaction of its business. In appropriate cases not covered by rules of the Assembly, the rules of the University Senate shall apply."

SACUA: "The committee may adopt rules for the transaction of its business."
