9:02am-9:15am: Call to Order, Approval of Agenda and Minutes

The agenda was approved. The minutes for the April CFEI meeting were approved. The Chair introduced the committee and provided a brief overview of the purpose of the committee. Each member of the group introduced themselves.

9:15am-9:44am: Discussion of committee charges, and what the committee would like to focus on this academic year

<u>Summary</u>: The Chair introduced the Charge. She provided some of the history of the committee and the items that had been focused on in the past. A large focus this year will be on DEI efforts across all of the campuses. There will be some focus on priorities worked on in years prior, as well.

Scheduling a meeting with Tabbye Chavous was mentioned as a priority.

A suggestion was made that perhaps an initial meeting with the full CFEI group take place, and then have individually designated members follow up. Discussion followed regarding if having the meetings with both officials
