<u>Summary</u>: Luke provided an update on the senate restructuring. The recent vote on proposal 2 by the Senate Assembly passed. A vote in late May will occur with the University Senate. There will be a meeting prior to the vote in which advocates and detractors are able to make their case for or against the membership expansion. At this time it has not been scheduled, but it will be soon.

An overview of the resolution was provided. The amendments were discussed. Luke answered various questions posed by the committee. Should the resolution pass the University Senate vote, the Regents will need to approve a change to their bylaws for these changes to go into effect. If the Regents have changes they propose, it would need to be presented to the Senate Assembly by the Chair.

Nuances regarding the potential changes were discussed, particularly regarding the library unit, as well as Dearborn and Flint.


## 10:27am-10:45am: Committee priorities for next academic year
