3:05 SACUA Chair Update

- Met with CSG President Meera Herle and CGS Vice-President Bipasha Ray.
 Chair plans to meet regularly with them for the rest of the year, including the Monday after Thanksgiving. They discussed issues of concern and are planning next steps for working together. He plans to invite them both to a Senate Assembly or SACUA meeting and he in turn will attend a student government meeting.
- 2. The Chair and Vice Chair attended their first President's Council meeting. Faculty governance, student governance, staff and administration from all three campuses were represented. Under discussion was Tim Lynch's statement on academic freedom, the campus plan and vision statement. There was ample time for member input on all of the topics. They were polled regarding frequency of meetings and asked to solicit meeting ideas. There were 25 or so in attendance.
- 3. The chair and FSO director have been meeting with faculty who have reached out to them regarding Generative AI. Since the report came out from the Generative AI Advisory Committee there has been a surge of interest in the topic. They wanted to discuss deeper issues such as how this will define learning and what learning will look like at UM.
- 4. The FSO director (with support from the chair) is asking the Provost's Office for an additional person in the FSO office.

- SACUA supports the AAAC continuing its work on reviewing the four SPGs named in the AAAC recommendation;

University of Michigan Bylaws of the Board of Regents, Sec. 5.02: Governing Bodies in Schools and Colleges Sec. 4.01 The University Senate

"...[t]he Senate is authorized to consider any subject pertaining to the interests of the university, and to make recommendations to the Board of Regents in regard thereto. Decisions of the University Senate with respect to matters within its jurisdiction shall constitute the binding action of the university faculties. Jurisdiction over academic polices shall reside in the faculties of the various schools and colleges, but insofar as actions by the several faculties affect university policy as a whole, or schools and colleges other than the one in which they originate, they shall be brought before the University Senate."

Rules of the University Senate, the Senate Assembly and the Senate Advisory Committee on University Affairs:



Senate: "In all cases not covered by rules adopted by the Senate, the procedure in Robert's Rules of Order shall be followed."

Assembly: "The Assembly may adopt rules for the transaction of its business. In appropriate cases not covered by rules of the Assembly, the rules of the University Senate shall apply."

SACUA: "The committee may adopt rules for the transaction of its business."
