**FSO Welcomes New Director**

In July, Chair Pedraza introduced SACUA to the new Director of the Faculty Senate Office (FSO), Lucas J. McCarthy. In an [University Record interview](#) with Directory McCarthy,

SACUA's imprimatur. Published on June 6, they stressed the need for U of M to have a central Office for Ethics, Integrity, and Compliance with a reporting line to the Regents to avoid the sexual misconduct problems in the past. It was also discussed with Tami Strickman, Director of the Office of Institutional Equity, Civil Rights, and Title IX (ECRT).

Chair Pedraza said it was precisely Luke's combined background of a J.D. and Ph.D. degree that made him a perfect candidate for the position. Luke McCarthy earned his law degree from Florida State University and has M. A. and Ph. D. degrees in English literature from Western Michigan University. For six years, he worked as an attorney representing the boards of municipalities, businesses, and homeowners' associations.

### **SACUA Letter on Faculty Governance at UM-Flint**

At one of its summer meetings, SACUA discussed the concerns generated at UM-Flint by the transfer of various departments housed under the College of Arts and Sciences (CSA) to the College of Innovation and Technology (CIT) without knowledge of the faculty or its input. As a result, SACUA wrote a letter to the Regents, the Provosts and the Chancellors on the three UM campuses, our interim President Mary Sue Coleman, and the newly chosen President Santa J. Ono. In that letter, SACUA decried the loss of mission clarity for both CIT and CAS faculty and the lack of input from the faculty on their campus regarding the direction the institution would take in the future as well as the

consequences for the departments left behind in CAS. SACUA continues to look at the situation in Flint closely.

The Syllabus Insert is an effort endorsed by SACUA and led by SACUA members Rebekah Modrak and David Potter, together with students who survived sexual abuse by the faculty, in order to protect the students in the future. The Syllabus Insert is optional for faculty to add to their syllabus, specifying the boundaries of the student-faculty relationship outside of the classroom. The effort has meant a great deal to the students who have survived these damaging relationships.

### **New Faculty Orientation**

On August 28, Chair Pedraza and Vice Chair Singer attended the New Faculty Orientation and shared a “University Senate: We Are the Voice of the Faculty” handout to attendees.
