

Committee on Anti-Racism Minutes

September 9, 2024 (regular meeting), via Zoom

- 1. Call to order and there were no objections to approving the minutes.
- 2. Welcome from Chair Germain Awad and CAR introductions
- 3. CAR 2024-2025 Charge discussion included the following topics:
 - There is concern that national trends are impacting the U-M Regents without data to support claims, such as attacks on diversity statements. There is a U-M committee looking at diversity statements and Chair Gigi Awad also serves on this committee.
 - CAR raised questions about what kind of data is available and how to best measure the impact
 of diversity initiatives, outcomes, and change over time, including: data as important for
 accountability; data on U-M faculty of color leaving U-M and identifying factors for faculty
 retention; the importance of addressing structural issues; there are also communication issues,
 especially at such a large university; Interest was expressed in working with ODEI; how to create
 and measure efforts that have an actual meaningful impact?
 - Disparities across the Ann Arbor, Flint, and Dearborn campuses regarding diversity efforts, racial climate, and faculty of color recruitment and retention.
 - Challenges with the U-M administration not acknowledging and/or addressing anti-Arab racism
 and the importance for CAR to address anti-Arab racism. At the federal level, there is a <u>new</u>
 <u>Office of Management and Budget (OMB) policy</u> for collecting data on race and ethnicity and the
 need to correctly understanding the nuances and shortcoming of available data.
 - CAR plans to continue its work on pursuing a race-based misconduct U-M report to be prepared
 by the Equity, Civil Rights, and Title IX (ECRT) office similar to its Title IX report on sexual and
 gender-based misconduct.
 - It can be challenging to know about all of the U-M antiracism and DEI efforts given compartmentalization and decentralization at U-M.
 - 4. Action Items and Next Steps
 - By the October 10th meeting, CAR members will compile publicly available DEI and anti-racism data and metrics to help inform how CAR will focus its efforts for 2024-2025.
 - Chair Gigi Awad will contact ODEI-VP Chavous regarding CAR 2024-2025 planning and to ask about scheduling a CAR meeting with the Vice Provost.
 - CAR member Matthew Spradling will share info. via email about benchmarking of DEI at Ann Arbor, as compared with Dearborn and Flint.
