Chair Marsh said the Chancellors of UM-Flint and UM-Dearborn have been invited to attend separate SACUA meetings, Chancellor Grasso of UM-Dearborn has responded and will attend a meeting that will be divided between open and executive sessions. Professor Schultz asked if local faculty governance would be invited to those meetings. Chair Marsh they would not be as they can already talk regularly with their chancellors.

Professor Beatty will chair the Senate Assembly meeting as Chair Marsh will be away. Professor Schultz asked about the naming of members to the Tri-campus task force and rearranging the Senate Assembly Agenda in the context of the approval of other committee memberships. Chair Marsh said the members have yet to be identified.

Discussion Series with the President and Provost

Chair Marsh opened discussion of the proposed discussion series for faculty with the president and provost by saying Professor Schlissel is willing to engage with faculty in various fora. In addition to promoting more robust communication on campus and raising SACUA’s profile, such meetings would have the coincidental effect of making it possible to obtain a quorum for a University Senate meeting at which business could be transacted.

Presently, the President and Provost are scheduled to meet Senate Assembly in December 2018 and March 2019 respectively, Chair Marsh asked if these Senate Assembly meetings should be opened into Senate meetings, which would be widely publicized. Professor Conway asked if the President and Provost would still attend the Senate Assembly if they spoke at a separate University Senate meeting. Chair Marsh replied that they would still attend the Senate Assembly; the proposed meeting was an additional commitment for the President for which President Schlissel has volunteered to make the time. Professor Lippert asked if President Schlissel had topics in mind. Chair Marsh said that the proposed topic was the University budget, though Chair Marsh feels that such a topic might be more appropriate for the Provost, and that the President might offer a discussion of his vision for the university along the lines of speeches he gives elsewhere. Professor Lippert suggested that President Schlissel could discuss the whole institution while the Provost discussed the budget for the Ann Arbor campus. She also suggested that it would be helpful if both the Provost and President could discuss the role of faculty governance. Professors Potter and Schultz suggested that events could be advertised as open houses to see how robust attendance would be at a separate Senate Assembly/University Senate meeting. Librarian Spencer asked about how faculty perceive their workload and how constituencies might be targeted to encourage participation. Professor Potter said such an event could be advertised as a conversation with President Schlissel. Professor Schultz suggested that an event might also be arranged at which Central Student Government (CSG) would be present while President Schlissel offered a discussion of the “state of the university.” Professor Carlos suggested that faculty be asked to submit questions so that they feel better engaged with the meeting, and expressed a preference for using a Senate Assembly/Senate Assembly so that there would be a Senate quorum. She also suggested charging Senate Assembly members with getting their colleagues to come to Senate Meetings, and raised the possibility of having competitions between units to encourage attendance.

Professor Malek asked about email communication with the faculty. Chair Marsh said he would be sending an email to the faculty introducing them to SACUA. Professor Lippert asked about the inclusion of UM-Flint and UM-Dearborn faculty on the senate mailing list. Chair Marsh said they will be included.

Chair Marsh said that the October Senate Assembly meeting would be given over to a Regents’ Candidates Forum and asked if this could be a full University Senate meeting because the Regents’ Forum would draw more faculty. Professor Conway pointed out that this Senate Assembly meeting was on fall break for the Ann Arbor campus. Chair Marsh said the date was chosen because of a specific request from one regental candidate.

Professor Carlos suggested that a theme for the year should be points of conflict and the Grievance system. She proposed that SACUA should invite Mr. Frumkin, Associate Vice Provost for Academic and Faculty Affairs and Director of Academic Human Resources (https://www.provost.umich.edu/about/senior_staff/frumkin.html). Professor Schultz suggested invitations for Professor Weineck to discuss the grievance process, and Jerry May before he steps down from his position as Executive Vice President for Development (<https://leadersandbest.umich.edu/careers/aboutdev/jerrymay>). Professor Lippert suggested that CSG be invited (and, possibly, student governance groups from the other campuses). Professor Malek suggested that Robert Sellers, Vice Provost for Equity and Inclusion and Chief Diversity Officer (<https://odei.umich.edu/robert-sellers/>) be asked. Chair Marsh said breakfast settings would be preferable for meetings with the Regents.

University of Michigan Bylaws of the Board of Regents, Sec. 5.02:
Governing Bodies in Schools and Colleges
Sec. 4.01 The University Senate

"...[t]he Senate is authorized to consider any subject pertaining to the interests of the university, and to make recommendations to the Board of Regents in regard thereto. Decisions of the University Senate with respect to matters within its jurisdiction shall constitute the binding action of the university faculties. Jurisdiction over academic polices shall reside in the faculties of the various schools and colleges, but insofar as actions by the several faculties affect university policy as a whole, or schools and colleges other than the one in which they originate, they shall be brought before the University Senate."

Rules of the University Senate, the Senate Assembly and the Senate Advisory Committee on University Affairs:
Senate: "In all cases not covered by rules adopted by the Senate, the procedure in Robert's Rules of Order shall be followed."

Assembly: "The Assembly may adopt rules for the transaction of its business. In appropriate cases not covered by rules of the Assembly, the rules of the University Senate shall apply."

SACUA: "The committee may adopt rules for the transaction of its business."
